A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MORGAN HILL APPROVING THE FINAL MAP OF CALLE SIENA – TRACT NO. 10293, AUTHORIZING THE CITY MANAGER TO EXECUTE AND ADMINISTER THE SUBDIVISION IMPROVEMENT AGREEMENT WITH GLENROCK BUILDERS, INC., AUTHORIZING THE CITY MANAGER TO EXECUTE AND ADMINISTER A STORMWATER BEST-MANAGEMENT-PRACTICES (BMP) OPERATION AND MAINTENANCE AGREEMENT SUBJECT TO REVIEW AND APPROVAL OF THE CITY ATTORNEY, AND AUTHORIZING THE RECORDATION OF THE FINAL MAP, THE STORMWATER BMP OPERATION AND MAINTENANCE AGREEMENT AND THE SUBDIVISION IMPROVEMENT AGREEMENT

WHEREAS, the City of Morgan Hill, a municipal corporation and general law city duly organized and existing under and pursuant to the Constitution and laws of the State of California ("City"), is authorized to enter into contracts and agreements for the benefit of the City; and

WHEREAS, the reasons supporting the approval of the final map and the entrance of the City into those certain agreements described in, and that are the subject of, this Resolution are set forth in detail in that certain City Council Staff Report entitled "Final Map Approval of Calle Siena – Tract No. 10293" submitted for City Council consideration at its meeting of August 5, 2015 , submitted to the City Council by the City Manager (the "Staff Report"), the contents of which Staff Report are incorporated herein by this reference; and

WHEREAS, the consideration by City Council of the adoption of this Resolution has been duly noticed pursuant to applicable laws and has been placed upon the City Council Meeting Agenda on the date set forth in the Staff Report, or to such date that the City Council may have continued or deferred consideration of this Resolution, and on such date the City Council conducted a duly noticed public hearing on the adoption of this Resolution at which hearing the City Council provided members of the public an opportunity to comment and be heard and considered any and all testimony and other evidence provided in connection with the adoption of this Resolution; and

WHEREAS, the City Council determines that adoption of this Resolution is in the public interest.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MORGAN HILL DOES HEREBY FIND, DETERMINE, RESOLVE AND ORDER AS FOLLOWS:

- <u>Section 1</u>. <u>Recitals</u>. The City Council does hereby find, determine and resolve that all of the foregoing recitals are true and correct.
- <u>Section 2</u>. <u>Approval and Authorizations</u>. The City Council does further resolve, order and/or direct as follows:

- a. That the Final Map Approval of Calle Siena Tract No. 10293 attached hereto as Exhibit A and incorporated herein by this reference (the "Map") is hereby approved; and
- b. That the Subdivision Improvement Agreement with Glenrock Builders, Inc. for Calle Siena Tract No. 10293 ("Subdivision Improvement Agreement") substantially in the form attached hereto as Exhibit B and incorporated herein by this reference is hereby approved; and
- c. That the City Manager is hereby delegated authority to and is authorized and directed to execute and subsequently administer the Subdivision Improvement Agreement substantially in the form attached hereto as Exhibit B; and
- d. That the City Manager is hereby delegated authority to and is authorized and directed to execute, and subsequently administer, a Stormwater BMP Operation and Maintenance Agreement ("Maintenance Agreement"), subject to review and approval by the City Attorney, substantially in the form attached hereto as Exhibit C; and
- e. That the City Manager or designee is hereby authorized to and is directed to file the Subdivision Improvement Agreement, the Maintenance Agreement, and the Final Map of Calle Siena Tract No. 10293 with the Santa Clara County Recorder's Office.

<u>Section 3</u>. This Resolution shall take effect immediately upon adoption.
