A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MORGAN HILL ORDERING THE FINAL REPORT ON THE 2015 WEED ABATEMENT PROGRAM ASSESSMENT REPORT BE TRANSMITTED TO THE SANTA CLARA COUNTY ASSESSOR'S OFFICE AND THE LIENS BE POSTED AGAINST THE PROPERTIES ON THE REPORT

WHEREAS, on August 5, 2015, the City Council confirmed the Santa Clara County Department of Agriculture and Environmental Management's Final Report on the 2015 Weed Abatement Program for APN 729-18-030 and 729-18-031; and

WHEREAS, this report identifies properties in Morgan Hill where hazardous weed and brush inspections and/or abatement were conducted by the Department's contractor in accordance with the 2015 Weed Abatement Program; and

WHEREAS, property owners listed on the Final Report were notified of the public hearing conducted on August 5, 2015; and

WHEREAS, properties requiring abatement by the Department's contractor are to be assessed the abatement cost via a lien on their property taxes;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MORGAN HILL DOES HEREBY FIND, DETERMINE, RESOLVE AND ORDER AS FOLLOWS:

Section 1. Recitals. The City Council does hereby find, determine and resolve that all of the foregoing recitals are true and correct.

Section 2. Adoption of Final Report and Program Charges. the Final Report on the 2015 Weed Abatement Program Assessment Report, attached hereto as "Exhibit A" be transmitted to the Santa Clara County Assessor's Office, and that the Santa Clara County Assessor's Office post a lien against the properties on this list in accordance with the appropriate statutes

Section 3. CEQA. That the City Council hereby finds based upon the facts and information in the record for this Resolution that the approval of the Community and Cultural Center energy efficiency project is categorically exempt from environmental review under the California Environmental Quality Act pursuant to California Code of Regulations, Title 21, Section 15308 (Actions by Regulatory Agencies for Protection of the Environment.)

Section 4. This Resolution shall take effect immediately upon adoption.
