A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MORGAN HILL ORDERING THE FINAL REPORT ON THE 2015 WEED ABATEMENT PROGRAM ASSESSMENT REPORT BE TRANSMITTED TO THE SANTA CLARA COUNTY ASSESSOR'S OFFICE AND THE LIENS BE POSTED AGAINST THE PROPERTIES ON THE REPORT

**WHEREAS**, on August 5, 2015, the City Council confirmed the Santa Clara County Department of Agriculture and Environmental Management's Final Report on the 2015 Weed Abatement Program for APN 767-21-015; and

**WHEREAS**, this report identifies properties in Morgan Hill where hazardous weed and brush inspections and/or abatement were conducted by the Department's contractor in accordance with the 2015 Weed Abatement Program; and

**WHEREAS**, property owners listed on the Final Report were notified of the public hearing conducted on August 5, 2015; and

**WHEREAS**, properties requiring abatement by the Department's contractor are to be assessed the abatement cost via a lien on their property taxes;

<u>Section 3.</u> <u>CEQA.</u> That the City Council hereby finds based upon the facts and information in the record for this Resolution that the approval of the Community and Cultural Center energy efficiency project is categorically exempt from environmental review under the California Environmental Quality Act pursuant to California Code of Regulations, Title 21, Section 15308 (Actions by Regulatory Agencies for Protection of the Environment.)

Section 4. This Resolution shall take effect immediately upon adoption.
