A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MORGAN HILL SUPERCEDING RESOLUTION NO. 15-125 TO REPLACE THE MEMORANDUM OF UNDERSTANDING WITH THE MORGAN HILL POLICE OFFICERS' ASSOCIATION AND CORRESPONDING SALARY SCHEDULES FOR THE TERM JULY 1, 2015 - DECEMBER 31, 2018 IN ITS ENTIRETY

WHEREAS, the Memorandum of Understanding and corresponding salary schedules with the Morgan Hill Police Officers' Association was ratified by the City Council on June 3, 2015 ("Original MOU"); and

WHEREAS, a provision regarding Specialty Pay was left out of the text of the Original MOU; and

WHEREAS, the Original MOU should be updated to reflect the agreed upon provision regarding Specialty Pay.

NOW THEREFORE, BE IT RESOLVED:

Section 1: The City Council adopts and incorporates herein the findings in the recitals.

Section 2: The City Council hereby ratifies, and authorizes the City Manager to sign, the revised Memorandum of Understanding with the Morgan Hill Police Officers' Association for the term July 1, 2015 through December 31, 2018, attached hereto as Attachment A. The attached revised Memorandum of Understanding shall replace the Original MOU in its entirety and Resolution No. 15-125 is hereby superseded.

Section 3. If any section, subsection, subdivision, sentence, clause, phrase, word, or portion of this resolution is, for any reason, held to be invalid by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this resolution and each section, subsection, subdivision, sentence, clause, phrase, word or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivision, sentences, clauses, phrases, words, or portions thereof be declared invalid.
