A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MORGAN HILL APPROVING AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE, EXECUTE AND ADMINISTER THAT CERTAIN SECOND AMENDMENT TO AGREEMENT FOR ADMINISTRATIVE SERVICES TO SANTA CLARA VALLEY HABITAT AGENCY FOR CLERK SERVICES AND INFORMATION **SERVICES** SUPPORT, **DELEGATING** AUTHORITY TO THE CITY MANAGER TO ENTER INTO CERTAIN **FURTHER AMENDMENTS** TO **THAT AGREEMENT**

WHEREAS, the City of Morgan Hill, a municipal corporation and general law city duly organized and existing under and pursuant to the Constitution and laws of the State of California ("City"), is authorized to enter into contracts and agreements for the benefit of the City; and

WHEREAS, in 2013, City and Santa Clara Valley Habitat Agency ("Agency") entered into that certain "Agreement for Administrative Services To Santa Clara Valley Habitat Agency" for City to provide certain clerk services to the Agency for the period of October 1, 2013 through September 30, 2018 for the reasons and in the manner described therein ("Agreement"); and

WHEREAS, in 2015, City and Agency entered into that certain "First Amendment to Agreement for Administrative Services To Santa Clara Valley Habitat Agency" to amend the Agreement with this Amendment in order to provide Agency with the information services support and website maintenance services that were included in the agreement for Administrative Support Services to the Santa Clara Valley Habitat Agency that is being terminated; and

WHEREAS, the City Council determines that adoption of this Resolution is in the public interest.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MORGAN HILL DOES HEREBY FIND, DETERMINE, RESOLVE AND ORDER AS FOLLOWS:

- <u>Section 1</u>. <u>Recitals</u>. The City Council does hereby find, determine and resolve that all of the foregoing recitals are true and correct.
- <u>Section 2</u>. <u>Approval and Authorization</u>. The City Council does further resolve, order and/or direct as follows:
 - a. That the Second Amendment to Agreement for Administrative Services to the Santa Clara Habitat Agency for information services support and website maintenance services incorporated herein by this reference (the "Second Amendment") is hereby approved to add and include certain information services support and website maintenance services.
 - b. That the City Manager is hereby delegated authority to and is authorized and directed to execute the Second Amendment, that the City Manager is hereby further authorized to administer the terms of the Second Amendment, and that the City Manager is hereby further delegated authority to and is authorized to

> enter into additional amendments to the Second Amendment to further extend the term and/or to account for changes necessitated only by approved changes in City employee salaries or benefits.

<u>Section 3</u>. This resolution shall take effect immediately upon adoption.
