Subject: Meeting 9/2 Agenda input - Against Oak Meadow Annexation

City Council,

You will be reviewing this Wednesday a recommendation from staff on a requested annexation for development that has been kicking around since 2006. This is coming with a no recommendation from the planning commission because of the serious issues with it. On more than one occasion and as recent as the Jan 13th 2014 page 6 the recommendation from the planning staff was complete denial. I ask you to review the Sept 9th 2014 staff report which sites several issues with this in violation of the general plan. In the staffs report it states this is inconsistent with the following items and gives a detailed explanation as to why:

Goal 2, Policy 2A and Action 2.2,

Policy 2c - Protect views of hillsides, ridge lines and prominent natural features surrounding the city. These features help define the City's historic rural character, sense os place, image, and identity Action 2.6 - The highest priority areas for Greenbelt preservation include the eat side of El Toro, the Edmundson/DeWitt/Sunset Area, and the foothills on the eastern side of the valley north of Dunne Ave

Policy 2P, Action 2.17, Action 2.18, Goal 4, Policy 4B


This site was reviewed by GPAC and 14-0 voted this should not be targeted for development.

This was recorded as a matter of record. This land has been in contention since is was brought in as part of a ULL project without neighborhood review including the review and signing of an MOU. Now the ULL has been disbanded so should this project.

Community involvement

They staff report does not include the city council meeting from April 19 2006 where this whole site was MOU'd and ULL with very specific caveats from the city council direction and agreement from the developer around working with and reaching agreement with the community. Community involvement was a divide and conquer promising cul-de-sac to some streets and the second time around sent someone through the neighborhood trying to get them to sign something (38 homes) with tactics that backfired and created outrage in the neighborhood. This person is specifically angling to have a road from this proposed development to access the back of their county property. Where is the neighborhood on this proposed development?

85% confirmed opposition

Trail -

Staff stated they changed their tune because of the trail, the trail has been in discussion and part of the proposal since 2006. We met with the Community Developer Chris Ghione and he said this trail link was not meant to have parking when they designed the map and it was purely for the neighborhood to access - by which logic we should have a say at what cost, and surely not when it mean having to walk most of it though a development that blocks view sheds. This was pushed to be master trail plan map by the developer to get points not by neighborhood it would provide access too.

Morgan Hills input in general input – Over 1750 petition signature - To date we have been circulating issue around the community starting on the 4th of July and started an online petition at change.org (http://tinyurl.com/SaveMorganHill). Just like the GPAC, a group that includes people in development, the rest of the community is against this annexation. I will bring the pile of signatures to the meeting.

Subject: Save Morgan Hill - Vote No - OakMeadow Annexation

City Council members,

I am a Morgan Hill resident and local business owner. I'm writing this letter on behalf of the Save Morgan Hill Movement. Save Morgan Hill's focus is to responsibly grow the city of Morgan Hill by utilizing the Smart-Growth guidelines outlined in Morgan Hill's General plan. If the Smart-Growth guidelines are adhered to, the City of Morgan Hill has sufficient land for residential development within its current City limits based on LAFCO's (Local Agency Formation Commission) 2013 review of vacant lands inventory. At that time, the City had enough vacant residential land to accommodate growth for 18 years (based on city's definition) or 33 years (based on how LAFCO considers vacant lands).

Additionally, the Save Morgan Hill movement is sponsoring a petition and ballot measure that would put annexation applications for development of county land to a general vote by the citizens of Morgan Hill. This will allow an opportunity for everyone with a stake in the long-term viability of Morgan Hill to participate in the city's growth.

An example of this is the Oak Meadow annexation and development request. For nine years the annexation and development requests for Oak Meadow have been denied by the City staff and planning commission. Due to continued back door lobbying by the developer, the City planning commission redefined the definition of "infill". This redefinition is significant and was done without input from the residents of Morgan Hill. Given this new definition of "infill" the developers will be able to destroy Oak Meadow and other agricultural/grazing lands that are surrounded on only one side, rather than three sides in the previous definition. Recently, a \$100,000 grant was awarded to study the climate and infrastructure consequences of developing at-risk lands in Morgan Hill, Gilroy and Coyote Valley. Given this upcoming study and repeated concerns from LAFCO that Morgan Hill fails to preserve the desired amount of open space, we respectfully ask that the development of Oak Meadow be delayed, until the results of the study can be considered.

In summary, Save Morgan Hill is not anti-growth, we are pro-Smart-Growth. Our goal is to work with the City Council members to responsibly grow Morgan Hill while adhering to the Smart-Growth framework in the City Plan, which states the importance of "Preserving the rural character, open space and hillsides."
