- 3. Section: Open Space 2: Project is located within 115% of the response standard for a second fire station. Award 0.5 Point.

The project committed to two improvements, Bus Shelter and Bus Pull out area under the premise it would receive two points. Applicant agreed to two improvements outlined in the criteria in anticipation of receiving two points. Award 2 Points.
