Item #32: Spay and Neuter Program

I want to speak in support of Ms. Geddes' request. As I said to her this weekend, it is unfortunate that neither the new 2035 General Plan (Healthy Communities Element and Natural Resources and Environment Element) nor the County General Plan Health Element acknowledge that the welfare of animals (domestic and wild) contribute to the health and happiness of humans.

I hope your support will be a first step toward more regional involvement, in particular with the County Animal Shelter in San Martin.

Back in May and June 2013 I asked the County Sheriff (HLUET) and Chief Swing (Mayor Coffee) if the money that they were going to spend on housing police dogs at Elmwood and in Morgan Hill could be re-directed to facilities at the Animal Shelter.

Unfortunately, neither even pretended to consider how this could be possible, and immediately responded that they were too special.

I hope the Council, for the health of our animals and ourselves, will try to see what we could do and not just fall back on why we can't do.

Item #33: Minimum Wage Community Outreach and Engagement

As I finished sending my written comments on the two forums last week, I realized that the last thing I said should be the first question to you: what is our ultimate goal? If the goal is to reduce the number of working poor, is minimum wage the best starting point to achieve that?

I would like to hear more about the two alternative approaches brought up by the business community: starting wage, minimum wage, living wage total compensation

Before I can take a position on minimum wage, I would like us to participate in the regional study if it answers several questions

- 1) Who considers this a regional issue and why? Who does not consider this a regional issue and why?
- 2) Is there a flow at boundaries of jurisdictions with different minimum wages of sales and of jobs?
- 3) What are the unintended consequences and are they offset by net benefits?

For example, an article in the "Bakersfield Californian" on Nov 29 suggests that minimum wage hike in Oakland could reduce access to childcare.

Given that the staff report mentions other Bay Area cities and includes the SCC Cities Association Report on Minimum Wage, don't you think that an additional Council Priority would be Regional Involvement? I would suggest that Regional Involvement does not equate to Regional Consistency. This differs from the position of the Cities Association, that regional consistency is a paramount consideration, since differences lead to economic competition (sales and jobs).

I thought the business and community forums went well (I attended all 90 minutes of the morning session but only the last 30 minutes of the evening session). Compliments to Kurt Lueneburger, Michelle Katsuyoshi, and Maureen Tobin. I did not feel the online survey was all that useful, since my questions (above) prevented me from having a position.
