Assistant City Manager for Community Development Leslie Little presented the report.

Vice Chair Williams stated for the record "I do not in any way suggest that it would not be good for the City to have this lot continue as a parking space. I think that its location does in fact help the downtown businesses. This is not in the least about the appropriateness of this parking, it's not in the least about whether the City should do this, but it is about whether or not this should be an obligation of the taxing entities. I believe that the taxing entities do not have any obligation whatsoever to provide downtown parking generically for the City of Morgan Hill. My belief is that it is time to end this and I think that the solution that staff proposed was outstanding in which the gentleman that is going to be the subject of our next conversation was agreeing to take over this lease to provide additional parking to make up for the parking that is going to be eliminated by his construction project. That is not my decision. That is the City's decision and Mr. Leal's decision. Should I vote to continue to pay an obligation to the City of Morgan Hill that I am not obligated to do, I think it is my fiduciary responsibility to not vote for that again."
