Dear Morgan Hill City Council,

Comments for the Public Record submitted by Doug Muirhead, a resident of Morgan Hill, for: Morgan Hill City Council Meeting Sept 07, 2016 Item #21: Sole source water AMI equipment and supporting services Thank you for your consideration.

I have never heard of a 20-year contract for anything other than property leases. This seems especially imprudent for technology that is evolving and may be subject to National standards.

When you say that the Council will receive a biennial summary of AMI system related purchases, you are also determining when our residents receive this information.

It was good to get more details on the pilot study to see if the sole source restriction can be eliminated. I don't understand why you would not empower utility technicians and authorize them to operate the telemetry network rather than using that lack as a justification for keeping sole source.

I would like you to request that the biennial summary also include:

- Missing from the pilot study was a comparison of system costs. You suggest that training and parts costs increase if multiple systems are used. But we do not see how your Sensus system cost compares to a total system from other vendors.
- 2) Other evaluations of Advanced Metering Infrastructure (AMI). For example, the Water District in 2015 awarded a Safe, Clean Water grant to San Jose Water Company (SJWC) to research real-time water usage technology and reporting (Project results available June 2017).
- 3) The pilot study noted that Mueller has its own AMI technology. ANSI is developing AMI standards (C12.22-2012). Updates on National standards and compatibility of your Sensus systems should also be evaluated.
- 4) You may be able to use material from the SCVWD Water Conservation and Demand Management Committee work plan item on Smart metering (AMI) and Leakages.
