2.1 Staff Report, Page 14, 2: Is 300% correct?

Using information from California Department of Education DataQuest for Morgan Hill Unified School District, the amount of graduates from FY 10-11 to 14-15 (latest information) that graduated with pre-requisite UC/CSU classes increased from 73 to

296, which is a 300% increase.
