A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MORGAN HILL APPROVING AND AWARDING A CONTRACT TO STB STONE, INC. FOR THE **CENTENNIAL RECREATION CENTER LOCKER ROOM** TILE FLOOR **PROJECT**, AUTHORIZING THE EXPENDITURE OF CONSTRUCTION CONTINGENCY FUNDS; AND AUTHORIZING THE CITY MANAGER TO EXECUTE THAT CERTAIN AGREEMENT WITH STB STONE, INC. FOR THE CENTENNIAL RECREATION **CENTER LOCKER ROOM TILE FLOOR PROJECT**

WHEREAS, the City of Morgan Hill, a municipal corporation and general law city duly organized and existing under and pursuant to the Constitution and laws of the State of California ("City"), is authorized to enter into contracts and agreements for the benefit of the City; and

WHEREAS, the reasons supporting the entrance of the City into that certain agreement described in, and that are the subject of, this Resolution are set forth in that certain City Council Staff Report entitled, "AWARD OF CENTENNIAL RECREATION CENTER LOCKER ROOM TILE FLOOR PROJECT," submitted for City Council consideration at its meeting of October 19, 2016, submitted to the City Council by the City Manager (the "Staff Report"), the contents of which Staff Report are incorporated herein by this reference; and

WHEREAS, the consideration by City Council of the adoption of this Resolution has been duly noticed pursuant to the applicable laws and has been placed upon the City Council Meeting Agenda on the date set forth in the Staff Report, or to such date that the City Council may have continued or deferred consideration of this Resolution, and on such date the City Council conducted a duly noticed public meeting at which meeting the City Council provided members of the public an opportunity to comment and be heard and considered any and all testimony and other evidence provided in connection with the adoption of this Resolution; and

WHEREAS, the activities allowed under this Resolution are categorically exempt from the provisions of the California Environmental Quality Act of 1970 per California Code of Regulations (CCR), Title 14, Section 15301, <u>Existing Facilities</u>; and

WHEREAS, the City Council determines that adoption of this Resolution is in the public interest.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MORGAN HILL DOES HEREBY FIND, DETERMINE, RESOLVE AND ORDER AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The City Councils does hereby find, determine and resolve that all of the foregoing recitals are true and correct.

<u>Section 2.</u> <u>Approval and Authorization.</u> The City Council does further resolve, order and/or direct as follows:

- a. That the Project Specifications included in the Council Staff Report are approved; and
- b. That STB Stone, Inc. is awarded the contract for the Centennial Recreation Center Locker Room Tile Floor Project; and
- c. That the Agreement with STB Stone, Inc. to furnish and install new porcelain tile floors in the locker rooms at the Centennial Recreation Center, substantially in the form attached hereto as <u>Exhibit A</u> and incorporated herein by this reference (the "Agreement") is hereby approved; and
- d. That the City Manager is hereby delegated authority to and is authorized and directed to execute the Agreement substantially in the form attached hereto as <u>Exhibit A</u>, provided, specifically, that the total amounts to be paid by City under the Agreement shall in no event exceed One Hundred Fifty Nine Thousand Two Hundred dollars (**\$159,200**); and
- e. That the expenditure of construction contingency funds not to exceed Fifteen Thousand Nine Hundred Twenty dollars (\$15,920) is hereby authorized.

<u>Section 3.</u> This Resolution shall take effect immediately upon adoption.
