Background

March 18, 2015 Council accepted the Staff recommendation to take a larger role in management of Senior Center operations and services for older adults.

September 9, 2015 the Older Adult Services Supervisor was hired.

November 18, 2015 Staff gave an overview on the Age-Friendly Cities Initiative and steps necessary to earn the City of Morgan Hill the World Health Organizations Age-Friendly designation.

April 6, 2016 Staff gave an update on the Age-Friendly Initiative and the Council adopted a resolution:

1) Designating Morgan Hill's commitment to become an "Age-Friendly" City;

2) Authorizing the Mayor to sign a letter of support; and


3) Authorizing the City Manager to execute the application form to the World Health Organization for designation of Morgan Hill as an "Age-Friendly" City.

June 24, 2016 the City of Morgan Hill earned the designation and joined the World Health Organizations Global Network of Age-Friendly Cities and Communities.


Why is the Age-Friendly Cities Project Important
