It is an effort to try and get to a higher farebox recovery, we have one of the lowest farebox recoveries in the country when it comes to public transportation. Our task as Council Members will be to stay engaged in that process to try and preserve as much of the public transportation that we have as possible. The VTA planning right now is headed in the direction of eliminating everything except express buses out of south county. It will be about a six month process. Council Member Carr has asked the VTA and their staff to be much more engaged with our community as they have these discussion and the VTA staff is currently working with City staff to setup a workshop before a council meeting so that the Council and community can be up to speed on the direction that these things are headed.
