Questionnaire Responses:

1) Describe background, listing the qualifications and skills, which you can contribute to the Commission.

In addition to attached resume, I would say that my diverse experience and education background could provide a unique perspective to the work of the Commission. Having relocated to Morgan Hill 3.5 years ago, I have sought out opportunities to become engaged in the development of our community – participated in cleaning waterways and pursued applying for a Creative Place-Making Mini-Grant at different times; most recently, I was part of the 2016 Leadership Morgan Hill cohort. My professional goals, in and out of my formal employment situation, are to contribute to the progressive development of communities, organizations and individuals. Serving as a Commissioner may allow me to contribute to these goals for my local community.

2) Have you served on any other citizen advisory commissions or committees?

I have not previously served on any citizen advisory commissions, or committees. However, in N'Djamena, Chad, I served as President and Vice President of the American International School Board; and, in Pretoria, South Africa, I served on the North American International School's Advisory Board. In Chad, the role of the board was to oversee the school's management and direction – including hiring and supervision of the director; in South Africa, the role of the board was to examine curricular issues, research and make recommendations to the school's owner and director.

3) What do you believe to be the role of the Commission, and why would you like to serve on the Commission?

As per the website, "the Planning Commission serves as an advisory body to the City Council on matters related to city growth and development, and on such other matters as may be requested by the council." "The City Council is committed to providing high quality and sustainable services to the entire Morgan Hill community. Fundamental to the City Council's success are the ongoing priorities of: enhancing public safety, protecting the environment, maintaining fiscal responsibility, supporting youth, fostering a positive organizational culture, and preserving and cultivating public trust." For 2016, the focus areas for the council were: "Planning Our Community, Developing Our Community, Enhancing Our Services, Improving Our Communication and Participating in Regional Initiatives." Serving on the Commission would permit me to become increasingly engaged in my community and contribute its on-going development. As referenced under #1, these goals are aligned with my professional and personal goals.

4) What skills and experience do you believe would be important to your role as a Commissioner?

I think that my professional experience and education background, combining private and public-sector human development, and social sciences with business principles, would be important to my role as a Commissioner. As the ultimate goal of a democratic government is to serve the best interests of its citizens, I am of the opinion that my skills and experience in international and domestic development are aligned with this goal.

5) How would you know if the Commission is successful in supporting the City Council's Goals?

As referenced under #3, the City Council's on-going priorities are: "enhancing public safety, protecting the environment, maintaining fiscal responsibility, supporting youth, fostering a positive organizational culture, and preserving and cultivating public trust." To discern "success" relative to these first five priorities and any strategic goals, I would recommend seeking and analyzing quantitative and qualitative

data; towards "preserving and cultivating public trust", I would recommend disseminating such information (whether positive or negative) to the public.

6) What would you like to accomplish as a member of the Commission?

I would like to come to a better understanding of the strategic priorities of my community, the challenges and opportunities that exist relative to these priorities, and assist in helping to facilitate the implementation of solutions to address the priorities, opportunities and challenges. I would like to assist in improving the functioning of the Council, the Commission and the local government's delivery of services to the community of Morgan Hill, and help the city to become recognized as a regional leader in local governance.
