Some agencies, as part of the process, publish a calendar of recurring reports. a) At the Council meeting on October 07, 2015, you expanded the scope of signature authority for the City Manager. Several Council members asked that a Best Practice of the County Board of Supervisors, to have a quarterly written report of how that authority was exercised, be a part of this new authority. No such report has been provided. b) At the Council meeting on August 24, 2016, you received a Development Services audit that included 160 recommendations, grouped into six key areas (53 priority number one recommendations, 82 priority number two recommendations and 25 priority number three recommendations). The report said that the #1 Opportunity for Improvement was: Agree on an implementation plan Unfortunately, Next Steps lacked any specificity: Implementation of the multiple service enhancements described above will continue. To ensure visible progress, Council Member Carr asked for a status report every three months. No such report has been provided. A new year. A re-invigorated Council. How about direction to the City Manager to renew and strengthen our transparency efforts. - - -Item #2: Fill City Council Vacancy Of the many ways you can evaluate the candidates, I would like you to look at whether you are building on strengths the Council already has, or whether you are adding new skill sets. I am in favor of expansion. And to that end I am in favor of appointing Caitlin Jachimowicz. I usually see Ms. Jachimowicz up on the dais at the Santa Clara County Parks and Recreation Commission. Her questions seek clarity. Her suggestions are to constantly improve a very good organization (County Parks). Many of our residents have expressed a strong desire for open space, trails, and parks. We share some common challenges with County Parks. And we will benefit from having a person who has regional perspective and experience. Just as the City Council does not run the City Enterprise, the County PRC is advisory to the Board of Supervisors.

Other applicants have touted their executive experience, perhaps not understanding that this position is not a superior/subordinate relationship. ---Thank you for your consideration, Doug Muirhead, Morgan Hill
