

**RESOLUTION NO.**

**A RESOLUTION OF THE PLANNING COMMISSION OF  
THE CITY OF MORGAN HILL APPROVING THE  
BUILDING ALLOTMENT FOR THE RESIDENTIAL  
DEVELOPMENT CONTROL SYSTEM (RDCS) ON-GOING,  
MICRO, SMALL PROJECT, OPEN/MARKET AND MULTI-  
FAMILY RENTAL (<150) PROJECTS FOR FISCAL YEAR  
2018-2019**

**WHEREAS**, the Planning Commission has received eleven project applications requesting residential building allotments pursuant to Chapter 18.78 (Residential Development Control System) of the Morgan Hill Municipal Code; and

**WHEREAS**, the City Council has established competition categories for open/market rate residential projects including a separate set-aside for small residential projects, micro projects and multi-family rental projects; and

**WHEREAS**, each residential project has been evaluated according to a specific set of standards and criteria as required by the Residential Development Control System; and

**WHEREAS**, the City Council has determined that the Planning Commission may adjust the distribution of allotments as deemed necessary to respond to changes in the housing market (such as changes in the build-out rate for existing projects, lack of applications in set-aside categories, and increased demand for particular housing types, etc.), provided no less than 33 percent of the allotment is awarded to single family dwellings; and

**WHEREAS**, testimony received at a duly-noticed public hearings, along with exhibits and drawings and other materials have been considered in the review process; and

**WHEREAS**, on January 10, 2017, the Planning Commission did duly adopt a Resolution approving the distribution for Residential Development Control System building allotments for Fiscal Year 2018-19; and

**NOW, THEREFORE, BE IT RESOLVED BY THE MORGAN HILL PLANNING COMMISSION OF THE CITY OF MORGAN HILL THAT:**

**SECTION 1:** Pursuant to City Council Resolution No. 16-080, the Planning Commission may adjust the distribution of allotments, which have been adjusted as follows:
