Dear Ms Ramirez,

I have been a resident of Morgan Hill for 17 years now. When we moved here we did think that it was odd that Depot and Church were so far off from each other and thought the intersection a bit "clunky" feeling. Over the years, and with the change of use for that corner (the building that was there now resides down the street from us), and getting used to it being the way it is, it has grown on us and in a way makes sense.

Right now I travel down Main Street from Monterey to El Toro Elementary 4 mornings a week. I drop my son off at 8 am, return directly to get my other son off to school and then return at 11 am to pick him up. If you are on Main Street around 11 am, it is a mostly pleasant trip. However at 8 am it is a mad house. People driving up the shoulder from the train tracks to make a right at Butterfield or driving up the left turn pocks and sometimes into oncoming traffic to reach the left turn pocket for Butterfield. You know have a left turn into the new development from Main Street and that just gums up the works sometimes. The traffic frequently backs up from the light at Butterfield back past the tracks and I have seen people stop fully on the tracks with almost no where to go if an unexpected train should come through. I fear that adding more and more residents in the Downtown area will just make this worse. I am sure the traffic on Dunne Avenue is just as bad already.

Tuesday and Thursday evenings we have an appointment Downtown. Used to we could park in the lot between 1st and 2nd Streets and have a short walk to the appointment. Now we must park in the 2nd and 3rd Street lot, if there is room, and hope it isn't raining and the lot isn't flooded. Kids do not like to hustle in the rain, nor do they pay attention to puddles. Some evenings we get there and the rush has started forcing us to the train lot. After our appointment we usually stroll around Downtown and find people fighting for parking places anywhere they can find, even if part of their car is in the road or blocking sidewalks and crosswalks. We have also found that people use Depot Street as an expressway and travel way too fast, sometimes barely stopping for stop signs and pedestrians. More residents Downtown will be straining the already strained parking and add more people trying to get home as fast as possible in the evenings.

I am really wondering the safety of adding so many high density housing up against the right of way for the train tracks. What if there was a derailment? Also has the final location for the High Speed Rail (don't get me started on how that is a waste of money) been decided? If the plan to align it next to the existing train tracks goes through, all the new building that has happened and is proposed will be razed.

Will the new parking structure gain parking spaces? During events, we need more parking on site as that lot can fill up quickly. With the new mixed use structure going in next to the parking garage, we will need more parking spaces than we have. As can be seen already, the Park and Ride lot on Butterfield already is full of people from the neighboring condos parking there. In California people do not park in their garages, they use their garages for storage. Very rarely do you find people parking in their garages. Sometimes if it is a 2 car garage you will find 1 car parked inside and 1 to 3 cars parked on the driveway or street. Most of the units on our street are 2 bedrooms with a couple of 3 bedroom. We all have a 1 car garage. Maybe 2 household use the garage to park. The rest do not. We frequently have parking wars because even though we have enough space for a car on the street in front our our unit, most people have more than 3 cars and I have had neighbors with 5 cars and a boat. The allotment for off street parking for these condos and other high density residential developments should be higher and not letting the developer pay a fine just to get away with subminimum spaces.

With all of our main artery roads, and the secondary roads that have become main roads due to the sheer number of development that has happened recently, needing serious attention, I cannot see spending the money to add more congestion Downtown. I have already memorized the pot holes up and down Monterey, Wright, Main and Condit among other streets I travel. I am already dreading the extra time and stress of drive to and passed Downtown. We have already passed up eating in Downtown because the parking is already full and at least one of our party cannot walk long distances.

Oh and stop pushing that things are close to public transit. There are only 2 Caltrain trains in the morning and 2 in the evening. The bus takes 2 to 3 times longer than driving (if you are lucky). There is no practical way to take public transit to Milpitas. Public transit in and out of Morgan Hill is almost worse than our internet options.

In summary, I believe the proposal to connect Depot and Church is not a

For 27 years we lived in Palo Alto and saw it transform from a laid-back town that was family friendly to a hectic crowded mess. The city planners changed their focus from maintaining the character of the community to rubber stamping any monstrous and crowded project submitted. We came to Morgan Hill to get away from that. We were looking for a smaller town rural experience. Please don't let Morgan Hill go the way of Palo Alto. The goal for town planners should be to make Morgan Hill a pleasant place to live, work and shop, not a sprawling bedroom community for San Jose.

In the almost two years that we have been here, I have seen a half dozen small businesses close in downtown. There is no point in revitalizing downtown and trying to attract new restaurants and shops to downtown if people don't linger there. Mayor and Council Members,

Regarding parking for housing developments, particularly in and around the downtown area, I'd like to remind the Council about the discussion that recently took place for parking issues related to the Depot-Sunsweet project. Part of that discussion included looking at changes to insure future developers provide sufficient on-site residential parking in order to lessen impacts on public parking in the surrounding areas. The Hale site proposes adding 61 residential units, but I do not see any specific references to residential parking in the agenda attachments. While it may be premature to include specific design concepts for residential parking, it isn't too soon to further that discussion.

Mr. Carr spoke during the Sunsweet development approval hearing of revisiting the current parking guidelines, giving attention to what I heard as more realistic expectations for the parking needs of residents in these medium- and high-density developments. While that may include his suggestion of a "parking program" for residents, having sufficient parking designed into these projects from the onset should be the focus. As much as it may benefit the City to collect revenue from in-lieu fees related to parking shortages, as happened with the Sunsweet project, it would be nice to see the Hale project designed to come forward over the minimum rather than fall short.

The Council would like to promote downtown housing along Depot Street (and Butterfield Blvd) as transit-oriented, but the fact is Morgan Hill is not part of a transit system that supports that concept. Public transit here does not provide the frequency or accessibility to encourage commuters to give up their cars. Nor does current transit operation support convenient, local access to shopping and recreational opportunities. This should be kept in mind not only by those selling the plans for these types of medium- and high-density projects to the city, but by the Council and City staff who are part of the development planning. Until public transit is improved in Morgan Hill, cars will be the main mode of transportation and will require places to be parked. Residential development at the Hale site should be the place where any new onsite parking standards begin and become established for future development.

Hi Edith,

My name is Jonathan Brusco, in addition to being a resident of Morgan Hill for the past several years, I am also a former library commissioner, county elections commissioner and current board member at Gavilan College. I am writing you in my capacity as both a citizen of Morgan Hill as well as an elected representative of it.

Let me first approach the Depot St. Development from the perspective of my representation of Gavilan college. I will begin by stating that this does not necessarily represent the full voice of our board, but I will be mentioning this development to the entire board tonight at our meeting. As you may be aware, Gavilan College is the largest current tenant of the Community and Cultural Center. We operate our local college facility in the CCC and are offer a number of classes at that facility. Since full development of our new Coyote Valley facility is still many years ahead, we will have many students attending classes at the CCC for years to come. The development of Depot street will make a serious dent in the CCC parking situation as well as likely increase the number of people loitering in the CCC, which is already a problem. Furthermore, I have yet to hear about this development plan at any of our board meetings, or through communications to our board, or to our school administration. I'm curious as to how you felt you could move ahead with this development without contacting your largest tenant in the CCC?

Stepping aside as a board member and now voicing my opinion as a citizen of Morgan Hill, I have additional concerns regarding this development. I will list them all below.

1. Decrease in accessible parking for the downtown area.

The building of 61 high density housing units along an already busy corridor of downtown would be an excessive strain on the parking situation. You're already cannibalizing a number of spots in the CCC and due to the nature of high density housing, you will likely find that residents will be more numerous, as will their vehicles. Parking will overflow into the surrounding areas and you will see an increased strain on the CCC parking situation, the downtown garage, as well as the VTA lot on the other side of the train tracks. There are commuters that use the VTA station for their daily needs, downtown visitors that will be discouraged from patronizing our businesses, and students/public visiting the CCC who will be unable to find parking. Furthermore, any attempt to enforce parking violation will be difficult due to the strain on the current police force and the lack of officers available to enforce violations. There may also be added danger of residents parking in the VTA and walking over an active train track to get to their homes.

2. Increase in loitering and potential crime.

The CCC already has its fair share of loitering, with many younger members of our community using it as a makeshift skate park. With the increase of 61 high density housing residences, you will only see this increase. Younger residents will loiter in the CCC, hang out near the tracks, the VTA lot, and congregate in other surrounding areas. With this you may see an increase in potential crime in the surrounding areas.

3. Traffic concerns and community events.

One of the appealing factors of our community are the numerous events that take place in downtown MH. These include the mushroom mardi gras, taste of MH, downtown music series, parades, etc... In all instances this brings a number of people downtown. Parking is already constrained during these festivals, and often the streets are closed off near the planned development. With 61 new residences in this area, all of these negative impacts will be increased. It will be harder to attend community events, more difficult to find parking, and as a result, many people will stop attending. Have you evaluated the impact this may have on road closures for these events? Have you done analysis of parking needs for major festivals?

4. Necessary increases in city resources.

I am not anti population growth, but a do believe that growth should not take place in Morgan Hill unless it is simultaneously aligned with an increase of all necessary city resources. Every time the city decides to move forward on a new building project that has a positive impact on our population, do they increase the police department, fire department, set aside money for road improvements, water resources, city services, etc...? I do not buy the excuse often given that our current resources are sufficient for X% of population increase because they simply are not. We do not have enough police on call, our roads do not support our traffic needs, and our city services are constrained as is. There's also a difference between a community that has adequate services and one that has plenty of services. I moved to Morgan Hill because of the small town feel of our community. The only way to maintain that feeling is to bolster our services in such a way that we can continue to provide our citizens with a town that is safe, pleasant, and quaint.

5. We are only one economic cycle away.

The economy moves in cycles, we have experienced recessions in the 80's, early 2000's, and in 2008-2012. We will have another one in the not so distant future. Our city is not preparing for this inevitability. Instead we build more homes in the up cycles, and then when it comes time to build infrastructure we are met with a downturn that limits that ability. What we are left with is a large strained population in a town built for 80% of that capacity. We need to plan for these cycles by simultaneously building our infrastructure along with our population.

Thank you for your time. I will be in attendance at your City Council meeting on Wednesday 2/15.

Below is my input on the Depot Street realignment.

Restructuring Depot Street and the CCC parking lot would be beneficial for the community. Currently, many people drive through the CCC parking lot to get onto Depot street from Church. This through-traffic is dangerous (even with the speed bumps), as people dive in and out of empty parking spots to get onto Depot Street. I am not a fan of adding more residences downtown though. I believe more residences would overcrowd the area.

I would like the city to seriously consider pedestrian safety if they move forward with this project. Any crosswalk, not at a light, should have a lighted walkway. Meaning, a pedestrian could push a button and have the crosswalk lit up with flashing lights. The city has not put pedestrian safety at the forefront of their projects. We would like to express our concern regarding the number of housing units being approved downtown and the effect on public parking and traffic. This month an 85-unit apartment complex was approved on the Sunsweet property and now we are considering a 65-unit housing complex just down the street. While both these projects include some parking, the Depot St project also takes away parking for the Community Center. It is also clear that these projects will not include all the needed parking for their inhabitants.

On top of that, the 2016 Parking Study concluded we will be seriously short on public parking once Leal and the developments currently being built are finished. And the Parking Study didn't even include parking for the Granada events!

We fear these residents will use street parking and the parking garage thereby preventing visitors to Downtown from finding parking.

Ms. Ramirez,

This would be a good time for the City to reassess its parking needs in the downtown area. I know there was a study done, and I for one feel it came up short in its analysis. The parking for the recently approved Sunsweet project showed parking is a) woefully inadequate for residential development downtown, and b) is calculated on numbers based upon the premise that Morgan Hill has adequate alternate transit to support commuters. In other words, the Master Plans and Specific Plans referring to a "transit-oriented" focus is half-hearted marketing for the benefit of developers. I personally feel the City should remove all language that uses "transit-oriented" from its reports and documents.

As was recommended by the Council during Sunsweet's approval, the number of residential parking spaces for high-density developments downtown should reflect the dependence on cars, not mass transit, and therefore should be reflected in the developers plans. Make it two spaces for every residence on site. As for the realignment of Depot, keep in mind that if the traffic isn't inconvenienced between Main and Dunne, it will just become another bypass not for Monterey, but for Butterfield. If it screws me up driving downtown for dinner, I won't go. As for another parking garage...inevitable. No more spider art, please.

When I first heard about this project my thoughts were all positive, but upon greater reflection I'm not sold on it because of the long term loss of publicly owned land it entails. The current community center parking lot is not only a parking lot, but is also a place where future community facilities could be located and is also temporary outdoor event space for things like the Mushroom Mardis Gras and Freedom Fest events. Any future needs to expand the community center would be drastically curtailed by removing the lightly improved land and replacing it with housing on the majority of the lot and a parking structure on much of the remaining piece.
