### **Comments**

- Preserve Park Land
- Land Bank for Future Passive Parks
- Peet Park is missing from the Project List
- Location of Public Parkland is important so people can get to it
- Rec Facilities + Sports Facilities - Citywide High School Sports Complex
  - Partner with MHUSD and Future Catholic High School on this at the OSC Area
  - Construct Bleachers
  - Improve for Regional Sports and High School Sports
- Rock Garcia presented concept on adding a Fishing Pond near Lake Silvera
  - Planning asked that he present to the PRC and Rocke said he would be there
  - Planning Commission liked the Fishing Pond idea
  - Be careful of CEQA requirements near lake Silvera relating to changes coming with flood control project
- Parking should be found for a trailhead locations for the El Toro Trail
- Passive Park Facilities are important and not addressed enough in the plan.
- Would like to see the 5 acres per 1000 resident level of service solely count passive parks
  - Find alternate funding sources for park maintenance so RDCS funds could be used for capital projects including passive parks.
  - Commissioners support reviewing alternate funding sources for park maintenance
- Commissioners noted the new RDCS may have funds for bikeway improvements
- Prioritize Bikeways
- More protective pathways versus buffered
- Do not like the ideas of demonstration gardens in parks
- Keep OSC Competitive make improvements at the facility
- Grow back space at HW Park where turf was removed and replaced with mulch several years ago
