City Manager Steve Rymer thanked the community for its water conservation efforts. He shared that in 2013 Morgan Hill consumed about 2.9 billion gallons of water. In 2016 we consumed 2 billion gallons for a savings of 0.9 billion gallons. That is an amazing statistic. Although we have received a lot of rain, we want to look at long term solutions and will be asking the community to look at ways of permanently reducing water usage to ensure that as we develop as a community we have the water resources that we need.
