REBUILD TOGETHER HOME REPAIR PROGRAM

RECOMMENDATION(S)

Adopt resolution authorizing the City Manager to enter into an agreement with Rebuilding Together for the implementation of a Senior Rehabilitation/Home Repair and Blight Busters Program.

REPORT NARRATIVE:

On May 18, 2016, the City Council approved staff's recommendation to authorize the City Manager to enter into an agreement with Rebuilding Together to provide Home Repair grants to Seniors, and a small scale Blight Busters Program. The agreement is for \$200,000 for a two year term (\$100,000 for grants, maximum \$7,500 each, \$40,000 for administration, \$60,000 for Blight Busters). This item was included in the May 18, 2016 City Council Agenda item number nineteen, "Housing Program Update." Council approved the recommendation provided by staff, however the resolution for this specific item was not attached to the report. The Resolution is attached to this report for Council action.
