FINAL MAP APPROVAL FOR THE COMMONS - TRACT NO. 10047

REPORT NARRATIVE:

The Commons - Tract No. 10047 is a 12 lot subdivision located at the northwest corner of San Pedro Avenue and Church Street (see attached site map). The development contains a short section of

private street, which was delineated in the original 2014 Measure C application. The private street will be built to a City approved standard section. The developer, Presidio Van Daele Monterey 12, LLC, has completed all the conditions specified by the Planning Commission in the approval of the Tentative Map on August 14, 2007.

The developer has furnished the City with the necessary documents to complete the processing of the Final Map and has made provisions with a Title Company to provide the City with the required fees, security, and insurance prior to recordation of the Final Map. Staff recommends that City Council authorize the City Manager to sign a Subdivision Improvements Agreement on behalf of the City and sign a Stormwater BMP Operation and Maintenance Agreement pending review and approval by the City Attorney.

COMMUNITY ENGAGEMENT: Involve

August 14, 2007 - Planning Commission approved Tentative Map. Residents within a 300 feet radius were informed of Planning Commission's intent to approve the tentative map for the project, in which a public hearing was held to give residents an opportunity to voice their concerns or comments of the tentative map requirements.
